OFFICIAL GENERAL MUNICIPAL AND SPECIAL ELECTION BALLOT OF THE STATE OF GEORGIA NOVEMBER 8, 2011

To vote, blacken the Oval (●) next to the candidate of your choice. To vote for a person whose name is not on the ballot, manually WRITE his or her name in the write-in section and blacken the Oval (●) next to the write-in section. If you desire to vote YES or NO for a PROPOSED QUESTION, blacken the corresponding Oval (●). Use only blue or black pen or pencil.

Do not vote for more candidates than the number allowed for each specific office. Do not cross out or erase. If you erase or make other marks on the ballot or tear the ballot, your vote may not count.

If you change your mind or make a mistake, you may return the ballot by writing "Spoiled" across the face of the ballot and return envelope. You may then mail the spoiled ballot back to your county board of registrars, and you will be issued another official absentee ballot. Alternatively, you may surrender the ballot to the poll manager of an early voting site within your county or the precinct to which you are assigned. You will then be permitted to vote a regular ballot.

"I understand that the offer or acceptance of money or any other object of value to vote for any particular candidate, list of candidates, issue, or list of issues included in this election constitutes an act of voter fraud and is a felony under Georgia law." [OCGA 21-2-285(h) and 21-2-383(a)]

Glynn County Special Election Special One Percent Sales and Use Tax (Vote for One)

Shall a special 1 percent sales and use tax be imposed in the special district of Glynn County for a period of time not to exceed five years and for the raising of an estimated amount of \$89,200,000 for the purpose of funding the acquisition, construction, and equipping of the following capital outlay projects: (i) road resurfacing for Glynn County and Jekyll Island, street milling and resurfacing for the City of Brunswick, sidewalks for Glynn County, and bicycle paths for Glynn County and Jekyll Island; (ii) improvements, upgrades, and expansion of water and sewer systems in Brunswick and Glynn County; (iii) improvements to the drainage and storm water systems in Brunswick and Glynn County; (iv) firefighting equipment and vehicles for Brunswick and firefighting and emergency medical service vehicles for Glynn County, (v) vehicles for the Brunswick Police, Glynn County Police, and Sheriff's Office; (vi) construction, renovation, expansion, and improvement of public buildings and facilities, including the County Public Works Complex, County Fire Stations, County Multipurpose Center at Selden Park, County Marina Launching Facility, Parking Lot Improvements at Coast Guard Beach, Airport Facilities and Property, Fishing Pier on Jekyll Island, Brunswick Recreational Park and Facility Improvements, Ritz Theater, Old City Hall, Brunswick Multi-Purpose Center; and (vii) purchase and provision of other equipment, including major equipment for County drainage and road maintenance, engineering scanner for Brunswick, County multi-use tractor, 911 Call Handling System, Computer Aided 911 Dispatch and Records Management Systems, 700 MHZ Radio Upgrade, County Network and Communications Infrastructure Enhancements and Improvements, LIDAR and Aerial GIS Imagery Updates and Equipment, and Emergency Operations Communications Equipment and Systems, all for the use and benefit of the citizens of Glynn County?
