### Application for Subdivision Review - Instructions

1. This form is to be used for all applications made on or after October 20, 2008. A complete application includes this form and all supplemental information.
2. Please fill in all lines and boxes on the form. If a section is not applicable, enter "Not Applicable" or draw a line through the section. On the first page, **please enter the name or company name under "Name" and list a contact person under "contact."** Please also enter an email address **for each member of the applicant team** - this will facilitate getting information on the progress of the application to all members of the team.
3. The application must be signed by the **owner of the property** or by the **authorized agent ONLY**. If the applicant is not the owner, be sure to include a completed Agent Authorization Form (page 3 provided in this packet).
4. If the project is not served by public water and sewer, a variance will be required. Submit a separate Water and Sewer Variance application form (page 4 provided in this packet).
5. Note that application materials will be accepted and reviewed for completeness. If an application is incomplete, processing may be delayed until it has been completed.
6. The following items **must be provided**:
  - Application Fee, if applicable (Fee Schedule attached)
  - Checklist for the type of application involved (the checklist will be reviewed for content prior to processing)
  - Proper number of sets of plans/plats
  - Deed
  - Tax Map
  - Water and Sewer Variance Application Form (if applicable)

#### GENERAL INFORMATION

- Applications will be received at any time and processed as soon as the initial review is complete. Applications will be scheduled for consideration after review.
- Applications for Preliminary Plat approval are submitted to the Planning Commission for approval.
- Applications for Final Plat approval are submitted to the Board of Commissioners.
- Applications for Water and Sewer Variances are reviewed by the Finance Committee and by the Board of Commissioners.
- All other applications and plans are reviewed and approved by staff.
