

REGULAR MONTHLY MEETING OF COMMISSIONERS ROADS AND REVENUE HELD TUESDAY, MARCH 5TH., 1940.

Minutes previous meeting read and approved.

Moved by Commissioner Royal, Seconded by Commissioner Abbott, to approve all disbursements for the period February 7, 1940 to March 5th., 1940, inclusive, in the total amount of \$19,184.45, covered by Vouchers #55587 to #55724. Unanimously adopted.

A delegation including Messrs. Wynne, King, Nathan, Holmes, Whittle, George and Others, appeared in the interest of modifying restrictions on Slot Machines. Mr. Winn requested that the (4) Slot Machines taken up from the King and Prince Club, be returned to him.

Moved by Commissioner Royal, Seconded by Commissioner Owens to refer to the County Attorney for investigating the State Law on Slot Machines and the possibility of placing the County Police under the Sheriff's Office. Unanimously adopted.

Moved by Commissioner Royal, Seconded by Commissioner Harley, to authorize the Clerk to Investigate the Claim of B.F.Mann in connection with the property encroachment at the Arnold Road and Ocean Boulevard and make the proper recommendations for action at the next meeting. Unanimously adopted.

Moved by Commissioner Royal, Seconded by Commissioner Harley, to appoint as Processioners for the 1356th. District Messrs.E.A.Mitchell, B.W.Murray, and E.L.Smith, in line with the Resolution of February 6th., 1940. Unanimously adopted.

Moved by Commissioner Royal, Seconded by Commissioner Paulk, to make payment to the Board of Education for interest on back taxes for the years 1932-1938 covering the period April, 1939-January, 1940. Unanimously adopted.

Moved by Commissioner Royal, Seconded by Commissioner Abbott, to accept \$100.00 in full compromise of all tax debts by the Estate of J.W.Goodbread for 1932-1939, in view of the fact that all the property of this Estate was set aside to the Widow as a year's support and the property so set aside becomes free of Tax Liens. Unanimously adopted.

Moved by Commissioner Royal, Seconded by Commissioner Harley, to refer the request of Mr. Carley Zell for Homestead Exemption on his house on St. Simons Island to the Tax Commissioner for handling. Unanimously adopted.

Moved by Commissioner Royal, Seconded by Commissioner Ratcliffe to authorize the Chairman and Clerk to investigate the possibility of improvements to the County Jail and legislation for the administration thereof. Unanimously adopted.


