Minutes of Last Meeting Read and Approved.

Rev.C.C.Davison, appeared with Colored Minister Burney, asking that the County make an Appropriation of \$90.00 to partly cover the expense of entertainment of Colored Baptist Convention to be held July 21st., and upon Motion request was granted.

Dr.H.L.Akridge, appeared stating that the special work being done by Representatives of the Rosenwald Fund would be discontinued shortly and that if the work was to be continued, it would be necessary to employ an extra Nurse. Upon Motion he was directed to employ the extra Nurse.
