THE FOLLOWING RESOLUTION WAS OFFERED AND ADOPTED:

Whereas it appears to this Board that there is a casual deficiency in the Revenue of this County for the Current Year and that it is necessary to supply said casual deficiency by a Loan or Loans to be paid out of the Taxes levied and to be collected for the Current Year.

Therefore, be it, and it is hereby resolved, that the Chairman and Clerk, be and they are hereby authorized to borrow the sum of \$25,000.00 from such person or persons as may advance the same, on such terms and at such rate of interest as may be obtainable.

The Following Resolution by Commissioner, T.J.Wright, was offered and Adopted:

Be it, and it is hereby resolved by the Commissioners of Roads & Revenue of Glynn County, Georgia, in regular meeting assembled, that there be, and is hereby levied and assessed for the year 1931, on all Real and Personal Property in said County subject to taxation, to provide the necessary revenue fro the requirements of the County, the follow- in taxes for the following purposes:
