Messrs. Millard Reese, A.M.Way, Walter Nathan and R.B.Setzer, appeared before the Board, stating that they represented the Welfare Board of the City of Brunswick and that they had received notice from the City Commissioners that after April 1st., 1933 no appropriations would be made to their board; they stated that unless the County would secure funds from the R.F.C. that great suffering would result, and urged that the Commissioners take steps to immediately secure such funds.

Mr. Setzer, Juvenile Court Officer made request for addition salary; request refused.

Rev.Dr.Lee, Capt.Rose, Salvation Army, and Rev. C.C.Davison, appeared, asking that all County Welfare Work be turned over to the Salvation Army and that funds be made available for them, suggesting that approximately \$15,000.00 annually would be needed.

Rev.C.C.Davison appeared asking for a contribution towards entertaining Baptist Convention to be held April 29th., & 21st. Upon motion, request was refused.

Rev.Dr.Lee and Dr.Purse representing the St.Simons Service Society, appeared, requesting that the County provide sufficient funds for the removal of Garbage on St.Simons the year round.

Request for Add in Savannah Morning News was received and refused.
