Be it, and it is hereby resolved by the Commissioners of Roads & Revenue of Glynn County, Georgia, in regular meeting assembled, that there be and is hereby levied and assessed for the year 1934 on all Real and Personal Property in said County subject to taxation, to provide the necessary revenue for the requirements of the County, the following Taxes for the following purposes:-

1.	To pay interest on bonded indebtedness,	.003330
2.	To pay legal indebtedness due or to become due,	.003000
3.	To pay any other lawful charges against the County,	.000225
4.	To pay Sheriff's and other Officers their fees,	.000452
5.	To pay Coroner,	.000050
6.	To pay expenses of the County for Bailiff's non resident witnesses in Criminal Cases, fuel, servant hire, stationery and other like expenses,	.000100
7.	To pay Jurors,	.000550
8.	To support the Poor,	.001000
