The following Resolution by Commissioner R.L. Ratcliffe was Offered and Adopted:-

Be it, and it is hereby resolved by the Commissioners of Roads and Revenue of Glynn County, Georgia, in regular meeting assembled, that there be and is hereby levied and assessed for the year 1936 on all Real and Personal Property in said County subject to taxation, to provide the necessary revenue for the requirements of the County, the following taxes for the following purposes:-

And, also a local School tax to be levied on all property outside of the Corporate Limits of the City of Brunswick, therein of .005 or \$5.00 on the \$1,000.00, being the rate fixed and certified to this Board by the board of Education of Glynn County.

Be it further resolved that all such taxes be collected by the Tax Collector of said County, or his successors in Office in the manner prescribed by law.

The following Resolution was offered and adopted:-

A Resolution authorizing the Commissioners Roads & Revenue, Glynn County, Georgia, to file an application to the United States of America through the construction of addition to P.W.A. Project No. Ga. 1042-R, and designating Malcolm B. McKinnon, Chairman or Francis L. Abreu, Architect, to furnish such information as the Government may request.

Be it resolved by the Commissioners Roads & Revenue, Glynn County, Georgia:-

Section 1. That Malcolm B. McKinnon, Chairman or Francis L. Abreu, Architect, be and they are authorized to execute and file an application on behalf of Commissioners Roads & Revenue, to the United States of America for a grant to aid in financing the construction of additions to P.W.A. Project No. Ga. 1042-R.

Section 2. That Malcolm B. McKinnon, Chairman and Francis L. Abreu, Architect, be and they are authorized and directed to furnish such information as the United States of America through the Federal Emergency Administration of Public Works may reasonably request in connection with the application which is herein authorized to be filed.
