## **Recovery & Re-entry Plan – 6:00 p.m.**

GLYNN COUNTY, Ga.- Glynn County Department of Public Works, Georgia Power, private contractors and other critical infrastructure operators continue working to restore services to Glynn County. Glynn County Emergency Management Agency continues to coordinate the recovery. Glynn County and City of Brunswick residents should be reminded that critical infrastructure providers continue to work diligently to fully restore services as soon as possible.

**At noon (12:00 p.m.) on Tuesday, October 11, 2016, Glynn County will implement Phase 3 of the re-entry plan for St. Simons Island.** Phase 3 is for resident re-entry. Only those who have proof of residency, or are employed by a business located in St. Simons Island and have proof of same, will be allowed access. An ID card, such as a driver's license, other government ID, or business ID, that shows your home address or business address on St. Simons is sufficient. An ID with a non-resident of Glynn County with your name matching a business card with a business address on St. Simons is sufficient for access. The policy is to allow for a reasonable limited access for those who have a legitimate need to re-enter for recovery purposes. **The check point for entry onto the island will be on Warde St. in Brunswick near the corner of US-17 and the FJ Torras Causeway.**

**As a reminder the boil-water advisory for St. Simons Island remains in effect until lifted by the JWSC.**

**A curfew will remain in place throughout Glynn County for the hours of midnight to 5:00 a.m.**

While crews continue to work to remove downed power lines and repair other infrastructure, it is important keep the safety of the utility workers and public safety officials in mind. Please give them space to work safely and remember the Georgia "Move Over" law.

County offices will reopen on Tuesday, October 11, 2016 for regular business hours. . There will be no Superior Court held on Tuesday, October 11, 2016 except the Cobb County trial which will begin at 9:00 a.m. All superior courts scheduled for Tuesday, October 11, 2016 will be re-scheduled for another day. The Superior Court Judges will be in there office for emergency hearings, signing of warrants, etc. State Court is canceled for the entire week. Magistrate Court will be held as normal (at this time) if any changes on it, you will be notified as far in advance as possible. The State Clerks Office and Superior Clerks Office will be open as per normal.

Glynn County schools will be will reopen on Monday, October 17, 2016.

- Thursday's regularly scheduled pick up from last week, will occur tomorrow Tuesday, October 11.
- Friday's pick up from last week will occur on Wednesday, October 12
- Monday's pick up from this week will occur on Thursday, October 13
- Tuesday's pick up from this week will be Friday, October 14
- Wednesday's pick up Saturday, October 15
- Thursday's pick up Monday, October 17
- Friday's pick up Tuesday, October 18

This pattern will continue until trash service is caught up.
