Pursuant to Uniform Superior Court Rule 16.1, undersigned counsel requests Leaves of Absence in the above-referenced case for the following dates and reasons:


**July 6 through July 10, 2020 for personal vacation; and December 24 through December 31, 2020 for personal vacation.**


