5. Jury selection will commence on **September 27, 2021 at 9:30 a.m.**
6. Trial will commence on **September 28, 2021 at 9:00 a.m. and shall continue through October 1, 2021.**

It is further **ORDERED** that jury selection shall take place at the designated courthouse annex building, Selden Park Gymnasium located at 100 Genoa Drive, Brunswick, Glynn County, Georgia; and jury trials shall take place in Courtroom Two at the Glynn County Courthouse, Brunswick, Georgia.

It is further **ORDERED** that negotiated pleas will not be accepted by the Court after calendar call on September 13, 2021.
